Purpose:

To update the Alliance members on work to date regarding the Investment Framework Project and to receive the draft report.

Background:

As requested by the Alliance, the EO developed an EOI for the provision of services to refine the Alliance's investment framework as a basis of a submission to the State and Federal Governments. After considerable deliberations and several meetings and a presentation by the two proponents (on the 7th of May 2020) the Alliance resolved to appoint Mainsheet Capital to undertake the contract.

Following their appointment in a special meeting held on 7 May 2020, MainSheet Capital have

- Met with Alliance members on 22nd May, after which an email was sent to each Council requesting information
- Met with, or spoken to the Executive Officer on numerous occasions
- Had meetings with each Alliance member, soliciting the necessary financial and project information for the submission
- Conducted other stakeholder engagement
- Provided a project update at the 18th June Alliance meeting, where they received feedback and guidance from members
- Provided a midway report
- Provided a draft report
- Met with Executive Officer on 24th July for draft report feedback
- A final draft was circulated on the 2nd August and is up for ratification at the 6th August 2020 Alliance meeting.

Discussion:

MainSheet Capital presented the draft Investment Framework document to the Executive Officer on 24th July 2020 and had a meeting with him on the 28th July to discuss feedback and refine document.

The EO has noted that as a result of consultation with members, government and other stakeholders, MainSheet have not incorporated any investment dollar asks from the state government, nor a fixed investment plan as was originally envisaged by the alliance as part of the EOI. MainSheet is developing a framework for investment to encourage government to invest through the capitals.

A presentation will be made by MainSheet to provide an overview of the document and will then take questions from Alliance members. A discussion needs to be held as to whether the Alliance wishes to have a dollar amount included.

The two-page glossy will be supplied after ratification of the framework document.

Purpose:

To discuss developments regarding the Planning Reform and members engagement with the working groups.

Background:

The Planning Reform process was initiated with an overarching objective to create a simpler, more transparent planning system. The Alliance has been aware of, and involved with, the Planning Reform activities since 2018. Throughout the last 2 1/2 years the members and the Executive Officer have made a submission to the Green Paper, collated a summary document that was presented to Kathy Bonus, met with Evan Jones, Gail McGowan, Graeme Gammie, Duncan Ord and David Michael, and attended Planning Reform meetings.

In August 2019, a Planning Reform Action Plan was released, with three overarching goals and 19 reform initiatives to achieve these aims and assist in achieving the State Government's priorities. The Action Plan was informed by consultation with stakeholders, advice from the WAPC and recommendations of the Independent Planning Reviewer published in the Green Paper in May 2018.

It was always the intention for the DPLH and WAPC to work collaboratively with stakeholders through working groups, reference groups and pilot projects to shape many of the reform initiatives; seek input on the detail and partnering to test options and identify preferred solutions.

Discussion:

This matter continues to be on the table. After numerous attempts to develop a white paper for consultation the Government decided to change tact. It formed a working group and developed several priority areas to look at reform issues. The EO and Mayor of Karratha City have attended several task force meetings to provide input from RCAWA.

Subsequently WALGA has been asked to provide nominations from Local Governments to participate in three focus working groups, namely:

- Local Planning Frameworks:
 - a. Local Planning Strategies
 - Manner & form
 - Timeframes

- o b. Local Planning Schemes & Amendments
 - Stream definitions
 - Timeframes
 - Report of review
 - New model definitions & zones
- o c. Local Planning Policies

12 A STRONGER TOMORROW STATE INFRASTRUCTURE STRATEGY DISCUSSION PAPER

Purpose:

To determine the Alliance course of action regarding engagement with Infrastructure WA (IWA) and the 20-year State Infrastructure Strategy Discussion Paper.

Background:

A ministerial media statement released by Hon. Mark McGowan, on 26th June 2020 announced the release of an Infrastructure WA discussion paper, the results of which will inform the progression of the development of a 20-year plan including an outline of how Infrastructure WA proposes to develop the state-wide long-term infrastructure strategy.

The plan is to be refreshed at least every five years, and will include recommendations that will focus on new infrastructure projects, programs and non-build solutions (e.g. strategic planning, policy, regulatory, pricing, technology, procurement, skills and governance reforms)

Strategic focus areas of the Discussion Paper include:

- the guiding principles and objectives that will help define the Strategy parameters
- the methodology and governance for developing the Strategy; and
- the priority opportunities and challenges the Strategy should address, particularly over the medium to long-term.

The release of the discussion paper marked the start of an eight-week engagement period, in which IWA will conduct 14 workshops across the State and seek feedback through an online submission format.

The discussion paper and its supporting documents, a feedback submission form and information about State-wide workshops can be found at https://infrastructure.wa.gov.au/DiscussionPaper. The Discussion Paper poses 22 targeted questions and is open to anyone who wishes to provide a submission on its onlineform by Friday 21 August 2020. There is also a short survey – which has been made available through social media and other avenues.
