In 2021 the Regional Capitals Alliance WA (RCAWA) commissioned a review of the operations of their Performing Arts and Entertainment Centres that had been significantly impacted by the Covid pandemic. Duncan Ord, former Director General of Culture and Arts, agreed to lead the review.

You may recall the review report was launched at the Rising Regions conference in Bunbury earlier this year.

The report has been well received by RCAWA members and key stakeholders and on their behalf, I am seeking to arrange a meeting with you, myself and Duncan to discuss some aspects of the review that fall within your Ministerial responsibility.

Being a long-standing champion of the Creative industries, you will appreciate that the 11 Regional Performing Arts and Entertainment Centres included in this study, having an asset value of \$600m and annual turnover of \$25m, play a critical role in regional communities supporting employment, education, entertainment, tourism, and local creativity.

The Regional Culture and Arts Investment program has been critical to the operations of the centres since 2008 and we would value discussing with you some improvements to the scheme by way of policy adjustments.

In addition, regional development commissions have been instrumental in the planning of cultural infrastructure and the review makes recommendations on gaps in regional capacity that would be of interest to you.

Further to your recent conversation with consultant Duncan Ord I am pleased to forward a link to the Regional Cities Alliance (RCAWA) review report concerning their Performing arts and entertainment centres. https://www.dropbox.com/t/vok5Ba0JOGFaYca6 or on the RCAWA website:https://waregionalcapitals.com.au/wp-content/uploads/simple-file-list/Reports/Regional-Performing-Arts-and-Entertainment-Centres-RPAEC-FINAL-3-WEB.pdf

The report was commissioned in late 2021 to assess the impact of the Covid pandemic on the centres and inform the alliance on ways to improve the operational performance of these centres to the benefit of their communities and the arts sector they serve.

The review identified the new Arts and Culture Trust legislation as an opportunity to improve the planning and delivery of regional arts infrastructure and mutually beneficial cooperation on programming, touring and audience development.

Specifically, the report suggested engagement between RCAWA and the ACT board.

- RCAWA engage with the new Arts and Culture Trust WA board on the potential for cooperation and support of venues managed by Local Government with the intention of building capacity, coordinating programming, increasing efficiency, and reducing risk.
- RCAWA seek to meet with the Board of the Arts and Culture Trust of WA to establish
 protocols for ongoing cooperation between the regional cities and ACT (WA) on the
 planning, construction, and operations of regional cultural infrastructure inclusive of
 museums, galleries, aboriginal cultural centres and performing arts centres.

In addition, the review recommends that RCAWA venues review ticketing systems compatibility with the ACT Tessitura system to potentially enhance audience development strategies.

The review identified the potential for new Performing arts infrastructure in Port Hedland and Broome and the opportunities that arise from the Busselton centre due to open in 2025.

The review also notes the impact of skills shortages on the capacity to support touring and live performance and recommended the establishment of a regional skills training hub. Following consultation with Circuit West a preferred model has emerged developed by the Victorian Arts Centre which is now supporting training for arts centres across Victoria. Circuit West will seek the support of ACT to potentially adopt the same model in WA.

RCAWA are engaging with Circuit West as the peak body for Performing Arts centres in WA with the intent that they lead on implementation of the report.

We would welcome an introduction to your recently appointed CEO and potential of a discussion at one of our monthly Alliance meetings.

- RCAWA seek PAC Australia support to lobby the Australia Council to lift the quantum
 of funding caps on touring grant categories in view of Covid related and world
 economic crisis cost inflation.
- Seek PAC Australia support to lobby the Office of the Arts and Australia Council to amend the Playing Australia funding criteria to fund intrastate touring to venues 250km or more from the capital city. This would better reflect remote disadvantage, assist the WA Indigenous arts sector, and encourage touring circuits to develop between WA and NT, SA and North Queensland

Further to your recent meeting with consultant Duncan Ord I am pleased to provide the following information from the Regional Capitals Alliance (WA).

The report was commissioned in late 2021 to assess the impact of the Covid pandemic on the centres and inform the alliance on ways to improve the operational performance of these centres to the benefit of their communities and the arts sector they serve.

The review acknowledged the leadership of DLGSC in the development of cultural policy and the delivery of cultural services and infrastructure to regional communities.

Specifically, the report proposed engagement with DLGSC on the following matters:

- RCAWA engage with DLGSC on the findings and recommendations of the Arts and Culture monitor survey that identified the need to improve access to the arts for regional audiences.
- The RCAWA advise DLGSC that direct funding of arts organisations designated for regional touring would release resources at the venue level that could be applied to greater investment in cultural diversity, first nations arts and arts for vulnerable communities.
- RCAWA engage with DLGSC and seek a review of current touring programs and arrangements that could be considered prior to the State considering the next tranche of the Regional Arts and Culture Investment program (RACIP).
- Seek State Government support to lobby the Office of the Arts and Australia Council
 to amend the Playing Australia funding criteria to fund intrastate touring to venues
 250km or more from the capital city. This would better reflect remote disadvantage,
 assist the WA Indigenous arts sector, and encourage touring circuits to develop
 between WA and NT, SA and North Queensland

 That RCAWA engage with DLGSC and DPIRD and seek the restoration of the Fit for Purpose capital funding program within RACIP and or the establishment of a Culture and Arts Facilities Fund.

The review has identified new Performing Arts Centre infrastructure is in the planning stage in Port Hedland and Broome with the Busselton Arts, Entertainment, and Conferencing Centre due to open in 2025. This significant investment in the future of the professional arts sector warrants close engagement with DLGSC and the Australia council to ensure optimal outcomes for the community, artists are achieved.

We have sought to brief the Minister for Culture and Arts Hon David Templeman on the review findings and would like to invite you to attend via a Teams meeting of the Board of the Regional Capitals Alliance and provide any comments on Departmental initiatives in regional arts and the matters included in this letter.

Further to your recent meeting with consultant Duncan Ord I am pleased to provide the following information from the Regional Capitals Alliance (WA).

The report was commissioned in late 2021 to assess the impact of the Covid pandemic on the centres and inform the alliance on ways to improve the operational performance of these centres to the benefit of their communities and the arts sector they serve.

The review acknowledged the leadership of WALGA in the development of a WA Cultural Development Framework policy and the importance of WALGA engagement with the State Government for a more equitable sharing of the funding of community arts and arts infrastructure.

Specifically, the report suggested engagement with WALGA on the following matters:

- RCAWA support the development of the WALGA Cultural development framework policy and submission to the State budget process for the establishment of a Community Arts and Culture Facilities Fund (CACFF)
- RCAWA to seek WALGA support through their Cultural development policy initiative to have the State address the inequities of current funding arrangements.
- RCAWA seek to engage with WALGA in supporting within their cultural development framework policies and guidelines on contributions from Local Governments that currently do not contribute but benefit from regional arts centre infrastructure and operations.

Purpose:

To update the Alliance on the implementation of the findings from the Regional Arts and Entertainment Centres review.

Background:

The Regional capitals Performing arts and entertainment centres play a critical role in supporting the vibrancy of the community, those who live within the city and those for whom the city is a services centre. Longstanding inequities in State and commonwealth funding support and the COVID 19 pandemic has significantly impacted the performance and viability of the centres placing increasing financial burden on local government.

The Alliance appointed Greensted services to undertake a review of the operating model of these centres and to make recommendations to assist COVID impact recovery, identify potential operational improvements and options for potential negotiations with the State Government for increased financial support as part of ongoing Regional Arts funding arrangements.

Status of implementation of the review findings

The implementation steering group has been expanded to include representation from the City of Greater Geraldton, Shire of Esperance, and Shire of Broome. The expansion led to greater focus on the capital works aspects of the report, and these have been included in revised priorities for implementation.

Circuit West attended the steering group meeting on the 19th July represented by Ms Phillipa Maughan the new CEO. Circuit West is a State funded Not for Profit peak organisation that supports both metropolitan and regional arts centres and facilitates and promotes touring. Circuit West has agreed to act as a facilitator for discussions with DLGSC on touring reforms. As the Chair of Circuit West is Ms Fiona De Garis CEO of BREC there is a strong alignment of interests between the RCAWA consortium of venues and Circuit West.

Engagement with WALGA through Nick Sloan CEO confirmed alignment between the RPAEC review and the WALGA Cultural Development Framework and Nick has undertaken to seek the inclusion of the proposed Community Arts and Culture Facilities Fund (CACFF) in the 2024 State budget submission. This will give strong local Government support to the DLGSC budget submission to establish such a program alongside the CSRFF program for sport and recreation.

Correspondence from RACWA to the Hon Don Punch Minister for Regional Development has led to a meeting set for 17th August. The focus of this meeting with be the Fit for Purpose capital funding and the recommended policy changes to the Regional Arts Investment Program funded through Royalties for Regions.



Correspondence to Hon David Templeman Minister for Culture and Arts has led to a meeting set for 23rd August. The focus of this meeting will be proposed reforms to regional touring funding, the Community Arts and Culture Facilities Fund, and State support for national reform of touring programs being progressed by PAC Australia.

The RACWA board requested a summary of actions arising and these are at attachment 21.

Key stakeholder engagement will be completed by the 23rd August.

Next Steps

It is proposed that RCAWA members enter a MOU to establish an ongoing cooperative forum for the 11 Regional Performing Arts and Entertainment Centres subject to the review.

The MOU will facilitate enhanced cooperation between RCAWA member venues and provide a single point of contact for Circuit West and DLGSC as they apply responses to operational and funding issues. Draft MOU attachment 19.

GOVERNANCE FRAMEWORK

Status of the Memorandum of Understanding

The Arts and Entertainment Centres MOU is established under the authority of the Regional Capitals Alliance (WA) Board of management.

Role and Function of the MOU Working Group

Membership

A Chair nominated from the Board of RCAWA, nominated council or venue officers representing a minimum of 60% of the participating RCAWA members.

Purpose

Ensure clarity by all parties about the purpose of the MOU and to report on outcomes to the RCAWA Board.

Requirements under the MOU

- 4.2 The primary functions of the Working group are to:
 - a) lead and provide strategic direction under the MOU;
 - b) be the custodian of the objectives of the MOU;
 - c) facilitate collaboration between RCAWA members in meeting the objectives of the MOU;
 - d) provide a discussion forum for engagement with key stakeholders;
 - e) establish the composition and nature of the work to be undertaken by any technical advisory committee.
 - f) advise on the appointment of any independent consultants to assist in delivering the MOU.
 - g) report to the RCAWA board on progress in delivery of MOU objectives.



Role of Technical Advisory Committee

Membership

Managers and nominated staff from each of the RCAWA member Performing Arts and Entertainment centre venues. Invited members from Circuit West, Regional Arts WA and PAC Australia.

Purpose

To enact the objectives of the MOU under the guidance of the working group and to provide technical and operational advice.

Requirements under the MOU

The role of the Technical Advisory committee is to:

- (a) provide a forum for discussion and joint action amongst the venue managers from each Participant;
- (b) provide operational advice and problem solutions as requested by the working group;
- (c) have a high level of awareness of emerging issues that affect the MOU, and of knowledge exchange;
- (d) contribute significantly to the achievement of the Strategic Goals and Outcomes of the MOU;
- (e) improve group cohesion; and
- (f) facilitate engagement with industry representative bodies and funding agencies.

Role of RCAWA Secretariate

Purpose

To administratively support the MOU working group

Requirements under the MOU

- 8.1 The role of the RCAWA secretariate or delegate is to:
 - (a) convene all meetings of the MOU working group;
 - (b) attend all meetings of the working group;
 - (c) organise the selection of personnel from the Participants to act as members of the MOU Working Group as determined by the Board and in consultation with the CEO's of the other Participants;
 - (d) advise the Board in relation to the functions of the working group;
 - (e) ensure that advice and information is available to the chair of the working group so that informed decisions can be made;
 - (f) liaise with the chairperson of the working group on any resourcing of the MOU.



- (g) speak on behalf of the working group if the chairperson agrees;
- (h) facilitate the role of industry peak bodies such as Circuit west in support of the working group and implementation of the MOU.

Meetings of the MOU Working Group

Purpose

To accomplish its purpose the Working group will establish an annual agenda in support of the objectives of the MOU.

Requirements under the MOU

Convening of Meetings

- a) A meeting of the working group will be held once every three months or as agreed by members.
- b) The RCAWA secretariate or their delegate is responsible for convening meetings of the working group.

Notice of Meetings

- a) The RCAWA secretariate or their delegate will provide each Delegate with at least 10 Business Days' notice of a meeting of the working group.
- b) The notice will specify the date, time and venue (or online) and include an agenda of the business to be considered.
- c) A Delegate may include an item on the agenda
- d) No notice or agenda is necessary if Delegates who represent each Participant and make up a quorum are present at a Board meeting and unanimously agree that a meeting be held and the business to be considered at that meeting.
- e) Delegates can request the invitation of key stakeholders to working group meeting to advance the objectives of the MOU.

Working Group Reporting

Purpose

Prepare a report annually on the progress of the MOU to inform the Board of RCAWA

Requirements under the MOU

The RCAWA secretariate or their delegate must, in consultation with the Board, prepare and provide to each Participant an end of year report setting out the progress of the MOU and addressing the matters referred to below:

RCAWA MEETING 24 AUGUST 2023



- (a) a description of the activities carried out by the Working group with reference to the objectives of the MOU;
- (b) a reasonable estimation of benefits derived from the operation of the MOU;
- (d) a brief description of the working groups planned activities for the next period, including details of any Projects anticipated to commence in the next 12 months;
- (e) any other information that the Board directs to be included; and
- (f) any other report the Participants may reasonably require to comply with their reporting obligations

Financial resources

Purpose

To ensure that there is no unauthorised commitment of member finances to the MOU.

Requirements under the MOU

Requirements

- (a) The RCAWA Board must approve any financial resources applied to the convening of the working group or technical advisory committee or actions arising.
- (b) The RCAWA Board must approve any applications for external funding associated with progressing the objectives of the MOU.

Discussion:

A Workshop meeting was held on 5 July 2023 with participants from most RCA members.

During the Workshop it was agreed that an effective pathway forward would be for Elysian Consulting to work with RCA members to identify key priority housing opportunities across RCA locations. This would allow the RCA to develop a Prospectus of Housing Opportunities through which the RCA could promote and advocate for additional housing investment from the Private, Non-Government and the State and Federal Governments.

Since the workshop, Elysian Consulting has developed a Draft Scope of Works covering the activities required to produce the Prospectus. The Draft Scope of Works is attached for discussion during the meeting. Greg Cash will attend the meeting to present the Scope of Works and to discuss the Prospectus in the context of the continuing housing crisis across the Country.

Draft Scope of Works

RCAWA - Regional Housing Opportunities Prospectus

Phase 1: Priority Housing Opportunity Identification

This Phase will be focused on direct engagement with key personnel of Alliance Members to identify priority Land and Housing Supply Opportunities and Projects within their Local Government boundaries that have the potential to:

- a) Bring forward available supply of land for urban development in the short term (2-4 years);
- b) Expedite the delivery of dwellings for:-
 - Social, affordable or specialist housing;
 - Key workers including low to moderate workers, emerging local industries and/or non-government workers;
 - Critical government service workers through Government Regional Officers Housing and Western Australian Country Health Service workers;
- c) Deliver general market housing supply for rental or home purchase.
- d) Enhance housing supply, increase housing diversity and revitalise Regional Centres through urban renewal and infill development.

This Phase will produce a comprehensive list of priority Land and Housing Supply Opportunities across Western Australia's Regional Capitals.

Phase 2: Project and Opportunity Analysis

This Phase will involve working with key personnel of Alliance Members to conduct analysis of each Project or Opportunity to identify:

- The scale and quantum of lots or dwellings to be produced.
- The housing and community outcomes to be delivered.
- Critical barriers or enablers required to facilitate Project or Opportunity development.
- Potential timeframe for delivery.

For this Phase, an individual project snapshot will be developed for each opportunity providing indicative base case project numbers and outputs. This will also allow for an overall snapshot of the potential statewide impact of the collective portfolio of projects.

Phase 3: Regional Housing Opportunity Prospectus

The Phase will seek to bring together an individual and collective view of all priority Land and Housing Supply Opportunities into a *Regional Capitals's Housing Opportunity Prospectus*.

The Prospectus will provide detail on individual opportunities and provide an overview of the collective impact potential of targeted investment in housing projects in Regional Capitals.

This will provide RCAWA with a key strategic document for engagement and advocacy for individual and collective investment in regional housing supply. It will support RCAWA in:

- Advocating to the State Government for investment in specific Land Development, Social Housing or Key Worker Housing Projects;
- Attracting investment in social and affordable housing through the Community Housing sector;
- Advocating for and promoting investment in Regional Housing projects to private sector development industry;
- Identifying pathways to attract State or Federal Government housing and infrastructure investment;
- Engaging with relevant Parties in the lead up to the 2024 State and Federal Government election campaigns.

Discussion:

Engagement with RCAWA Local Governments

BMac Consulting has conducted outreach to all ten RCAWA Local Governments to ensure a well-informed and effective template. Initial communication aimed to gather preliminary information concerning current service delivery practices. Subsequently, a review of the obtained information, including follow-up questions where necessary to ensure precision and clarity. For the Local Governments who had undertaken reviews, the feedback was relatively consistent that it is/was difficult to keep the momentum going with the reviews, or difficult to resource. It is also worth noting that 8 of the 10 Local Governments confirmed that they conduct community perception survey through Catalyse.

Insights from ACELG's Service Delivery Reviews

Discussions were held with a number of Local Governments over east who participated in the ACELG's "Service Delivery Reviews in Australian Local Government" in 2012. The purpose was to gain insights from their experiences with their review processes (noting that they weren't all using the same methodology), and to ask questions around alignment with Strategic Community Plans (SCP) and Corporate Business Plans (CBP). Feedback from these conversations consistently highlighted a common concern: the challenge of effectively tracking improvement of service delivery and the limited linkage to the SCP and CBP. This feedback has significantly influenced the objectives of the enhanced template.

Proposed Objectives of the Enhanced Template

Taking into account all of the feedback received to date, it would be beneficial to structure the template around the following key objectives:

1. Strategic Alignment

Acknowledging the importance of integration, the template could provide a structured method for aligning service delivery initiatives with the overarching SCP and CBP of each Local Government.



2. Meaningful Customisation

Incorporating SCP and CBP priorities would allow the template to be customised to the distinctive characteristics and priorities of each Local Government.

3. Progress Tracking

Addressing the received feedback, the template could incorporate mechanisms to monitor progress and improvement over time. This would offer a transparent and tangible means of showcasing improvements.

Next Steps

BMac Consulting will use the allocated time at the upcoming RCAWA meeting to host a mini workshop with CEO's to gather insights, suggestions, feedback and input before developing the draft template.

Following the workshop, the feedback and insights gathered from CEO's will be integrated into the template. A draft version will then be presented to the group for collective feedback and amendment. This process aims to ensure the final template is comprehensive and reflective of the collective vision.

Purpose:

To advise the members about the opening of the Most Accessible Community WA Awards (MACWA) and to encourage nominations.

Background:

At the August 2016 WALGA AGM, the City of Bunbury recommended that WALGA:

- 1. Develop assessment criteria to formally recognise the contribution that Western Australian Local Governments are taking to promote and improve accessibility within their jurisdictions.
- 2. Conduct an annual awards process coinciding with Local Government Week to recognise Local Governments nominated for work undertaken in no. 1 above based on metropolitan, regional, and remote categories.
- 3. Nominate the winning Local Government from each category for the National Awards for Local Government Disability Access and Inclusion Awards conducted by the Department of Infrastructure and Regional Development.

This item was carried and State Council resolved that the item be forwarded to the Planning and Community Development Policy Team for consideration. By August 2017, RCAWA had been asked to take carriage of this Award.

Discussion

The RCAWA Executive Assistant has been working with the Department of Communities, The Department of Local Government, Sport, Culture and Industry and WALGA since January this year – with the aim to get buy in for the promotion of the awards and ultimately to increase nominations from the sector. During this time Minister Punch has been briefed and has requested updates on the process.

Communities donated \$500 towards the design and input of the awards onto the RCAWA website and sponsors have been secured for award winners. An official launch was held at the lunch forum by the RCAWA Chair, Dennis Wellington.

The Departments and WALGA are now committed to communicate the awards over the next 3 months using the following information:

The 2023 MACWA awards are now open for nominations from Local Governments who wish to showcase their commitment to inclusive and accessible communities.

Based on Local Government Disability Access Inclusion Plans, the MACWA Awards seek to recognise those Cities, Towns and Shires who demonstrate that they have exceeded minimum legislative requirements with a creative and innovative approach to buildings and services, public open spaces, communication, and employment.
